Our Terms of Use

Please read the following Terms of Use carefully and fully before using: www.EarthView3D.net or any website or application powered by **UNB** in relation to EarthView3D, as well as other features and content offered from time to time in connection with EarthView3D (collectively, the "**Services**").

EarthView3D.net is used to view the earth in stereoscopic 3D with our patent pending technology. The current data set covers Canada, the United States (including Hawaii and Alaska) and Nepal. Potential applications include, but are not limited to: natural wonder exploration, geography education, road trip planning, disaster relief assistance, flight simulation, battlefield tactical assessment, border patrol, or simply exploring the beauty of the earth in 3D.

In these Terms of Use "**You**" and "**Your**" refer to any person or entity who downloads, views, uses, accesses, or browses any content or material from the Services. "**We**", "**Us**" and "**Our**" refers to **UNB**.
